

# Legislation:

From AMRA, via Minerals Make Life:



Nobody wants to see a huge scar on the surface of the earth that is visible from space. Small-scale miners are encouraged to fill in their holes when they are finished working on them. No other group can lay claim to cleaning the environment the way that small-scale miners do. We volunteer our time to go clean up other people's trash from the forests, rivers and campsites. We also remove toxic heavy metals such as lead and mercury from the watershed. Our equipment captures 98% of the liquid elemental mercury, (both naturally occurring and that which was lost during the 1800's) and nearly 100% of the lead. Those toxins are then no longer present to contaminate our drinking water or the food chain. Few, if any, other groups can beat our cumulative efforts to clean, restore and preserve the environment than the small-scale

miner. Ignorance of mining gives us a bad rap and we must all work to change that perspective into a truthful one.

Update on the Barstow BLM blocking the miners access to their real property mining claims:

As you all know, the BLM recognized the right to, and granted us access to our claims, then encouraged us to drive around the signs, then stated they would take pictures and submit an affidavit to the BLM Law Enforcement for prosecution for doing what they say we could do. There is a term for that in law enforcement, it is called "entrapment".

As you also are likely aware, they didn't show up when we challenged that fact. Didn't clear the roads like they said they would for the desert tortoise (so we did) and have no legal right to deny access to the owners, disabled and legitimate miners.

We've made it easy for them in this video. It is of AMRA President Shannon Poe driving around the sign and accessing the claim on that day in October.

We sent this video to the BLM and from the analytics, they seem to really view it a lot.
